22/23.56 Apologies for Absence

In relation to the Allotments rental fee, Cllr Berlyn proposed that the annual rent be increased to £20 from April 2024, Cllr Mrs Hallett seconded the proposal, one Member voted against the proposal, five Members were in agreement.

- ii) the rental fee for a Parish Council allotment plot be increased to £20 from April 2024

It was agreed that due to issues arising from land slippage, no planting (bulbs, wildflowers) has been budgeted for in 2023-2024; plan to be updated accordingly; Cllr Mrs Chapman will create a policy for responding to highways issues; Assistant Clerk will research/progress as applicable the other proposed actions.

Matters Reported:

- Road markings at Hyde Lane and Cherry Garden Lane still a concern, but lines at Landisdale have been reinstated
- Rotary Club planted 2,000 crocus bulbs at Elm Green between the trees and the A414; there was one volunteer from the village helping Rotary Club Members.
- Two volunteers have come forward: one for the 'Friends of the Community Woodland' and the second offering to help on both P3 projects and the community woodland (P3 and Friends of the Community Woodland will be on next agenda)
