In relation to the A414 Cllr Spence advised that following discussions consideration was being given to making the Well Lane zebra crossing into a traffic light-controlled crossing. He also advised that the lines were to be repainted and the beacons made brighter. Cllr Spence also commented on the proposed closure of St Peters Hospital in Maldon and noted that the original NHS consultation on the relocation of the maternity and stroke services did not mention the proposed closure once these services had been moved. Cllr Spence noted that it was hoped residents in Maldon would use the new statin at Beaulieu, once opened, rather than use the A414 to commute to Chelmsford station
