Cllr G Chapman has now surveyed the area and an order has now been placed for some sapling trees and the TCV will be providing a mix of smaller (60cm whips) traditional woodland trees. Costs to install trees (labour, mulch and sleeves etc.) being obtained.

To discuss: survey of wood diversity and as part of phase 2 of woodland management plan the construction of habitat piles, bat boxes and possible additional bird boxes.

School Governors have written to Cllr Spence giving approval for release of school land for the junction box that will be required for a traffic light-controlled crossing; approval from School Landlord (i.e. ECC) awaited. Letter of support for this new crossing also received from MP Sir John Whittingdale.
